Human Dignity

Human dignity expresses the intrinsic value of every human being. It is inviolable and must be respected and protected, as stated in Article 1 of the EU Charter of Fundamental Rights. We believe this universal principle rests on the human being as created in the image and likeness of God and is the cornerstone all the other human rights depend on. Therefore, life should be protected from conception to natural death. ECPM believes that a vibrant and positive Europe should celebrate and promote life. The EU Member States have sole competence over issues like abortion, reproductive care, mental health, palliative care, adoption and disability.





Healthy Families

ECPM sees the family as the most important social entity and the foundation for a thriving society. We call on the European Union to respect the sovereignty of the family, based on the marriage between one man and one woman. Family policy is foremost the responsibility of EU Member States and, according to the principle of subsidiarity, European institutions should not interfere. At national level, we stand for policies promoting parenthood: maternity leave, affordable childcare services and increased flexibility in the workplace for those who want to take care of their children. ECPM also supports programs focused on protecting children and youth, on preventing addiction and violence, and on advocating for children's rights.



Relational Economics

We believe the purpose of all economic activity is to support life and advance wellbeing for all- an economy that works for people and planet. We consider the principles of free trade and an open market are essential for Europe's economies, but believe there must be adequate checks and balances in place to protect the environment and address tax evasion. Economic policy needs to be people-centered, not driven solely by financial gains. Processes, contracts and projects need to be transparent, inclusive and democratic and not erode the rule of law. Technology must be developed and used fully respecting human dignity. ECPM believes that wise stewardship of Creation is a biblical mandate and that individuals as well as institutions have a responsibility to care for it.



Fighting Modern Slavery

Modern forms of slavery are dehumanizing, distorting relationships and severely hurting people. Most victims are trapped in forced labor conditions or sex trafficking. Since trafficking is a cross-border crime, combatting it requires international cooperation. ECPM strongly favors the implementation of the 2011/36/ EU Directive and the Nordic model approach in fighting sex trafficking. The Nordic model focuses on criminalizing the client and the trafficker. ECPM also calls for an EU-wide ban on advertising sexual services. EU Member States need to draft and harmonize legislation to eliminate child or forced labor from the supply chains.



Reforming the EU

We consider that the way the European Union works and acts needs to be reformed to enable it to be an instrument of peace and growth. ECPM believes more power and authority should be returned to Member States. Bureaucracy needs to be reduced by reviewing EU agencies and eliminating non-performing or redundant ones. The EU institutions should act more like facilitators and hubs for cooperation on transnational issues. The EU institutions and policies must adhere strictly to the principle of subsidiarity. We advocate for prioritizing EU Neighborhood Policy over EU accession for countries in the EU orbit.



Freedom, Security & Stability

Real freedom of faith, conscience and expression becomes apparent in interactions with those who feel, think or act differently. ECPM believes in the fundamental freedom to disagree with the view of the majority on any subject. We believe that implementing fundamental freedoms in volatile countries around the world would lead to greater stability and development. ECPM recognizes the need to support the security of Israel and its right to exist. We strongly believe that all European military operations should be conducted within NATO and that there is no need for a European army. We encourage increased collaboration between Member States on matters of border security, migration, (cyber)terrorism and organized crime.



Preserving Christian Heritage & Culture

ECPM acknowledges the Christian roots of the EU Members States and believes there is value in this heritage. Christian values like freedom, solidarity, reconciliation, love, truth and respect for life stand at the foundation of the European Union. We should celebrate and continue to build on these values and oppose secular, antireligious ideologies. We stand against Turkey becoming an EU member. Our party is concerned about the persecution of Christians worldwide, as well as the persecution of Buddhists and Muslims in some countries. We promote and advocate for freedom of religion or belief as a right for everyone, regardless of their religious beliefs. ECPM also defends the right to conscientious objection and reasonable accommodation as tools that ensure everyone has a right to manifest their religion or belief in public and in private.



Forward by the ECPM President

Dear ECPM members, colleagues, and friends,

At the beginning of each year, we have an opportunity to look back and a motivation to look forward. Søren Kierkegaard, a Danish theologian and philosopher said once: "Life can only be understood backwards; but it must be lived forwards". By putting together this booklet of activities and updates and taking time to reflect on them here, that is precisely what we are attempting to do.

The main challenge of 2021 continued to be the coronavirus pandemic. Since it started, hundreds of millions have been infected and more than five million died, globally. Behind these numbers are human lives lost, grief and heartbreak that cannot be quantified. We mourn and pray for all those impacted by this pandemic.

But despite this health crisis and many other difficulties we faced this year, we experienced a lot of blessings too, which prompt us to move forward with hope.

We're humbled and grateful for being kept alive. God helped many of us to overcome the virus. All the members of my family, including my wife and I, had to face this serious challenge. By His grace, we and many others recovered and were healed. Speaking of blessings, the altruism and stories of kindness we witnessed in our neighborhoods were touching and inspiring. The dedication of the health workers caring for the ill week after week is heroic and we are thankful for their service.

We continued to be blessed with peace in Europe this year, despite tension rising at the border between Poland and Belarus and the Eastern region of Ukraine being in turmoil again. Thanks to diplomatic efforts and international cooperation, the border issues were dissolved, and we continue to work and pray for a peaceful resolution in Ukraine.

ECPM organized a timely conference on the conflict in the Middle East as well. It was a discussion based on legal scholarly research criticizing EU's two-state policy on the Israeli-Palestinian conflict. The speakers expressed the need for peace in the region and gave examples of peaceful co-existence between Arabs and Jews but acknowledged much more needs to be done. For us, as followers of Jesus, it is important to not just pray for peace, but to also be peacemakers: "Blessed are the peacemakers, for they will be called children of God." (Mathew 5:9 NIV) There have been several changes inside the ECPM. I had the honor to be elected as the new President of the ECPM during the last general assembly.

I am thankful to everyone for the support I received, and also thank Branislav Škripek, my predecessor, for leading well the ECPM in the last four years. During the same assembly, we welcomed two new members on the party board: Leon Meijer and Michal Považan. I pray and hope that these changes will refresh and strengthen our Christian political movement. I am also very grateful for the work of our MEPs. Although many times their voice might sound like "the voice of one crying in the wilderness", their presence and efforts are vital in the European Parliament, given the fact that ECPM is the only European political party explicitly working on Christian values. Let us continue to pray for our members of national parliaments and European Parliament, for our partners and associates, for the members of the board, and for the wonderful staff we have.

It was encouraging to attend the annual European Prayer Breakfast (EPB) co-chaired this year by ECPM MEP Peter van Dalen and by MEP Roberta Metsola. The motto of the EPB "Let there be light in the darkness" resonates so much with our calling. We are empowered by Jesus to be the light of the world. The speakers' messages were both challenging and encouraging. It was extraordinary to see God's glory and majesty in both the small particles of our body and in the large, infinite Universe. Listening to them I was overwhelmed by a sense of wonder. The words of King David in Psalm 8 came to mind: "When I consider your heavens, the work of your fingers, the moon and the stars, which you have set in place, what is mankind that You are mindful of them, human beings that You care for them?" (Psalm 8:3 NIV)

We do not know what next year will bring, but we can be sure that God will be with us. He will walk with us, alongside us. Many years ago, King George VI of England, the father of Queen Elisabeth, addressed the British commonwealth on New Year's Eve at a moment in history when the whole world stood on the brink of uncertainty. Despondency and uncertainty filled the air and the king himself was seriously ill, unknowingly. In his New Year address, he said: "I said to the man at the gate of the year, 'Give me a light that I might walk safely into the unknown'. And he said to me, 'Go out into the darkness, and put your hand into the hand of God. It shall be to you safer than the light and better than the known." Let us continue our walk into the uncertain, unknown future of Europe by putting our hand into the hand of God!

Reflections on 2021

You, my brothers and sisters, were called to be free. But do not use your freedom to indulge the flesh; rather, serve one another humbly in love. For the entire law is fulfilled in keeping this one command: "Love your neighbor as yourself." (Galatians 5:13-14 NIV)

This year's debates, protests and discussions were oftentimes centered around the theme of freedom. Freedom in today's society is defined as having individual autonomy in absolute terms. All barriers that would limit this individual autonomy should be rejected, so that a person can feel they are truly himself or herself. This is a trend we unfortunately noticed this year in the controversial Matić Report on Sexual and Reproductive Health and Rights in the European Parliament.

But how is freedom related to individual autonomy? André Rouvoet, former Vice-

Prime Minister of the Netherlands (Christian Union) once made an analogy of a man who lives on a deserted island. This person has complete individual freedom, no rules and no other people who can limit his freedom. In the absence of fellow citizens, there is nothing that determines the contours of his freedom and also nothing to give his freedom a higher meaning. There is no one whose freedom he should care for or whose freedom affects his own. However, it won't take long before our islander will feel trapped, isolated and powerless.

One cannot really speak about freedom outside the context of relationships. But

then, relationships with others also limit the individual freedom. The Bible teaches us that real freedom comes through our salvation by Jesus Christ. He sets us free from our wrongdoings and restores the relationship with God and through this, our relationships with others. We see freedom as respon(d) sibility: we respond to God's love for us by loving our neighbor. As we are all created in the image and likeness of God, one's freedom should never harm another's human dignity or divide the society and communities we live in.

While the society at large is focused on freedom from anything that can limit personal autonomy, Christians see freedom as an act to love God and others. Because of this conviction, we stand up for the voiceless, unborn, refugees, trafficked or sexually exploited persons, the elderly, poor and disadvantaged persons in our society. To make sure that their voices are heard, and their human rights and dignity are protected.

But let's take this a step further. Let's go beyond advocating for their dignity in public speeches and actually take steps to ensure they find their place again in our society. In the Old Testament, freedom was seen as more than the opposite of slavery. The people of Israel were once slaves in Egypt until God liberated them. They were told to remember this when they dealt with the poor, widows or the strangers in their country. When slaves were freed in the Year of Jubilee, it was written: And when you release them, do not send them away empty-handed. Supply them liberally from your flock, your threshing floor and your winepress. Give to them as the LORD

your God has blessed you. Remember that you were slaves in Egypt and the LORD your God redeemed you. That is why I give you this command today. (Deuteronomy 15:13–15 NIV) That is the reason why this year the ECPM focused not only on the fight against modern slavery, but also on the urgent need for reintegration of persons who were trapped in prostitution or are human trafficking survivors.

Freedom is a fundamental value for us as Christians. Freedom from sin and shame in relation to God, and freedom to respond in love toward others. Freedom to stand up for the voiceless, poor and disadvantaged, and freedom for people freed from slavery to start a new life. We are called to the freedom which protects the unborn and the women pressed to terminate their pregnancies. Freedom for someone to act according to their religion or belief, freedom to not act against one's own conscience. We base this servant freedom on the freedom that Jesus Christ gave us through salvation. This is what motivates us and keeps us fighting. Are you in?

The Advisory Council (AC) was established by the ECPM General Assembly (GA) on June 7, 2013 and is a consultative group to both ECPM board and its members. It can propose topics for the GA and the board. It also checks the budget and the annual financial results. In addition, the AC checks and amends changes of program and statutes.

Usually, it meets at least two times per year. I would like to thank the ECPM board for appointing me president of the Advisory Council at the beginning of this year. I am honored to serve ECPM in this function, wonderfully represented by Heiner Studer

since its beginning in 2013. It is my hope and prayer that God will continue to guide us in every decision we must take and bless us with love and understanding for each other's differences, reminding us of the common goal that unites us: to preserve and promote Christian values in European politics.

Once again, 2021 proved to be challenging for the AC, given the Covid-19 pandemic situation. Because of the coronavirus restrictions and travel difficulties, the Council was not able to meet in person. In order to prepare for the General Assembly- which took place on May 28 via Zoom- we received

the documents in advance, studied them at home and provided guidance by e-mail. We held a common meeting online on May 19. Fortunately, we could support all the proposals the board submitted to the GA. We also welcomed with great pleasure the new AC members elected by the ECPM board, namely Annelie Enochson and Branislav Škripek, who are valuable additions to the Council.

In addition, we supported the proposal to re-elect the ECPM board members: Jacques Bazen, Ladislav Ilčić, Filip Łajszczak and Valeriu Ghileţchi, and advised the Assembly to re-appoint them.

In preparation for the second GA which took place in hybrid form on October 15 via Zoom and in person, the AC met virtually on September 24. We reviewed together the documents and proposals and was able to provide a positive report and support all the documents presented at the GA.



Even though we could not meet in person this year either, we had a positive and productive time during online meetings and were successful in the goals we had set out. For that we are thankful. Maria van Oost was an excellent secretary all this time and we are grateful for her ongoing support.

> We agreed to have the next AC meeting by the end of April 2022. God-willing, the Covid-19 pandemic will be under control by then and we hope to see each other face to face. Looking forward to humbly continuing to be a part of ECPM's work in preserving Christian values in European politics.





On the occasion of World Refugee Day (June 20), we wanted to take the time and space to highlight the stories and challenges of refugees, their families and of the people helping them. Many times, asylum seekers and refugees are numbers, statistics in a report, labels that people use to categorize, to politicize or to demonize. The goal with this event was to correct that narrative and to bring to the forefront the lived experiences of refugees, to raise awareness about the impact of COVID-19 on the legal process, on the living conditions and on the mental health.

We heard Shayan and Donya's story, refugees from the Middle East who settled in Croatia and the challenges they faced in the process. Shayan shared about their work and advocacy and the way they are paying it forward through their art, music and volunteering.

Ms. Bonamini shared the highlights and main takeaways from the JRS report on the situation of refugees in Europe during COVID-19, the barriers that came up and the different responses each of the EU member states studied had towards the refugees.



Entrepreneurship in a Pandemic series

Part 1: Solidarity vs. Accountability-EU's role in mitigating the economic crisis caused by COVID19





Deeply aware of the economic crisis Europe and the rest of the world is facing this year, we decided to organize a series of webinars focusing on the financial instruments the European Union set up in order to mediate the consequences of the crisis.

The two speakers in Part 1 of our series discussed the Recovery Fund (Next Generation EU) which, together with the Multiannual Financial Framework (the long-term budget of the EU), amounts to almost 2 trillion euros over the next few years.

Most of the money that will be made available in the Next Gen EU fund will be raised on the capital markets by the European Union borrowing large amounts of money at low interest rates. The fund will also be fueled by new taxes: a border carbon tax and financial transaction tax.



MEP Ruissen pointed to the fact that this extensive borrowing will create a large debt at the EU level which will be passed on to future generations. As of now, when the interest rates are low, this could be manageable but later on when the rates will increase, repaying the debt might become unsustainable and stifle innovation. The MEP also mentioned the political aspect of this recovery fund, namely that this will make the EU member states more dependent on Brussels and erode the principle of subsidiarity in the long term.

Mr. Gombacci, an Italian journalist living in Brussels and covering European Union news, pointed to the lack of solidarity between the EU member states when the pandemic started and said the recovery fund is absolutely necessary for the hardest hit countries, like Italy, since the member states depend and rely on each other economically.

The severe impact on the SMEs (which represent 90% of EU economy) was readily acknowledged by both speakers and they both agreed they should be helped quickly and effectively. Both guests agreed that the recovery funds should not be mis-used on projects that are not urgent or do not have a real usefulness.

Part 2: A Rocky Road to Recovery- How can the SMEs recover economically and how are the governments helping?

The second part in the series focused on the specific challenges SMEs** are facing in the different countries and how the recovery initiatives at European or national level are influencing that.

Each speaker took turns describing how the health crisis and the restrictions affected his business: closures, having to let people



go, shrinking the operations etc. They also spoke about the ways they had to re-adjust their operations, eliminate everything that was unnecessary, sell assets etc. just to stay afloat.

Speaking about the support they each received from their national governments, both guests listed the few stop-gap

measures but highlighted that it was insufficient and not robust enough to keep businesses going, nor was it timely. They also mentioned that business sectors which were not so adversely (or at all) affected by the pandemic restrictions received the same amount of grants, which the speakers deemed unfair and a misuse of funds.

Part 3: All in This Together. The Role and Impact of Entrepreneurs in Communities

The third installment of the series focused on the role and impact small and medium sized enterprises can have on the communities, an aspect which might be neglected at the EU level when it comes to disbursing the recovery funds.

In addressing the role of SMEs in their communities, Mr. Bassi focused on the family aspect as the example of proto-enterprise. He spoke of the family unit and how that can be a template for good management, how family-owned businesses are much stronger and more resilient in crisis because of the familial bonds that underpin them and how they can be the glue that holds a community together. He also addressed the issue of mental health and loneliness which the pandemic has exacerbated and advocated


for small or micro enterprises where these people can come together and start something beneficial for everyone involved.

Mr. Rise spoke about his family-owned hotel/ resort. It was initially bought and used to gather people together in studying the Bible, to be used as a church building at least partially. Serving people and God continues to be his motivation, even though the building functions now more like a regular hotel. He spoke of the importance of a family managing it as opposed to professional managers doing it; the sense of care and ownership is not the same. He chose to employ people who used to be drug addicts or had a difficult past, based on the idea that employment offers dignity and is the bridge to a better life for people who used to struggle.

The foundation Ms. Onu runs in Romania was started 26 years ago by families who had children or family members suffering from mental challenges or people with special abilities. They serve adults with Down Syndrome and autism, through two main services: day care center and residential services (housing). The foundation has also partnered with companies and private entities for which it provides copy and printing services, as a means to maintain financial sustainability.

The current COVID-19 pandemic greatly affected the trade between Georgia and the FII

Since 2014, when a free trade agreement was concluded between Georgia and the EU, Georgia has been steadily increasing exports to the EU, so that by the beginning of the pandemic, the European Union was finally Georgia's number one trading partner. In 2020, the volume of Georgia's trade fell by 26%, the largest share of that decline being represented by exports to the EU.

The Christian Democratic People's Party-CDPP (ECPM member party) organized this two- day conference to take an in-depth look at the drastic economic downturn and to discuss possible solutions. On the first day, speakers from the relevant departments of the Georgian Ministry for Economy and the Foreign Ministry presented trade figures for 2020 and first quarter of 2021, with the relevant data analysis. It was followed by a panel discussion with representatives of research centers and think-tanks who offered further analysis and presented strategies for recovery. At the end of the first day,

representatives of the business community were able to share their business and trading experiences during 2020.

The second day was dedicated to a wider, geopolitical analysis of the situation, where political leaders voiced their concerns about Georgia's possible increased dependency on the Russian and Turkish markets in the coming years, unless there is a reversal in the current trend. The day ended with a panel of experts and stakeholders who offered possible solutions and made a list of recommendations.





The Political Situation in Belarus within the European Context

The three-day event was organized in Warsaw, Poland in collaboration with BCD-Belarusian Christian Democrats.

The workshops and lectures focused on the pressure and retaliation against protestors in Belarus and possibilities for supporting them from the outside. A large number of Belarusians are forced to live in exile now in neighboring countries like Lithuania, Ukraine or Poland. In addition, the speakers looked at the political and diplomatic pressure attempted by the European Union. Sanctions have been imposed by the European Union on the Lukashenko regime and his proxies but some of the speakers presented examples

of loopholes and schemes the sanctioned people have found to evade the scrutiny. The ECPM Director for European Affairs – Leo van Doesburg – highlighted the fact that the most recent elections were not considered "free and fair" by the international community and the EU and United States have still not officially recognized the results. He also mentioned ways the European Union could further support the fight for democracy in Belarus and commended the protesters for their courage, especially Sviatlana Tsikhanouskaya who was awarded the Saharov Prize by the European Parliament.

The hybrid conference featured speakers contributing both online as well as in person.

The decline in the stability and security of the Eastern Partnership region (Ukraine, Georgia, Armenia and Azerbaijan) raised concerns in NATO and in the European Council. The two- day conference co-organized with the Christian Democratic People's Party- CDPP aimed to gather experts from the defense and security community in the region to discuss Russia's expansionist policies in Ukraine and Georgia, as well as a new defense and security architecture in the wake of the Armenia- Azerbaijan conflict.

On the first day, the various speakers focused on presenting analysis of the current developments in Eastern Ukraine (where Russia continues to have an increased military presence), of Russia's continued aggressive land grab policy in Georgia's occupied territories and of the situation in Nagorno-Karabakh after the peace deal was reached.

The second day was dedicated to discussing the EU's Common Security and Defense Policy in the face of regional challenges and its effectiveness. Speakers also focused on EU's response to Russia's expansion in the area and on NATO's response and policy towards aspiring members to the Alliance (Georgia and Ukraine).



The educational sessions are underpinned by a structure and activities that create relationships and friendships. EU-Georgia Relations Seven Years After the Association Agreement

Together with the Christian Democratic People's Party of Georgia (CDPP), we organized this seminar aimed primarily at young people and students of history, political science and/or European Studies.

The seminar was designed to provide detailed information and analysis on EU-Georgia relations to the young participants, on the 7th anniversary of signing the EU-Georgia Association Agreement (AA), as well as to project the future of the partnership. The Association Agreement was meant to foster closer ties and cooperation between Georgia and EU member states in the fields of economy, security, good governance, democracy and people to people contact. The Agreement went into force on July 1, 2014 while its agenda spans until 2024.

In the beginning, Georgia performed well, following the AA agenda efficiently, and the country enjoyed growth and stability brought about by a series of unprecedented reforms undertaken in the 2005–2012 period. From 2016, the implementation started slowing down, and after the 2020 elections, Georgia started backsliding on democracy and good governance.

The speakers focused on short-term and long-term action points Georgia should take in order to get back on track and allow its democracy to mature. While visa-free travel to the EU, trade agreements and educational exchange programs like Erasmus+ are Agreement results Georgians enjoy, this is an inflexion point where a decision must be made whether that is enough, or they want

to get closer to the EU. It was unanimously acknowledged that Georgia is still very far from EU membership, but that every effort must be made to get closer to the Union and its founding principles. In the meantime, the experts present suggested striving for realistic goals such as joining the Schengen area or joining some of the common agreements countries like Switzerland and Norway have with the EU.

Our member of European Parliament- Bert-Jan Ruissenhosted the annual conference organized by the Israel Allies Foundation, in collaboration with ECPM.

We organized this conference with the goal of clarifying a few aspects of international law pertaining to the land of Israel, the criteria of statehood and self-determination and to discuss what the EU's position vis-a-vis the decades- long conflict has been and what it should be.

The Israeli ambassador emphasized the importance of the Abraham Accords for the Middle East region and urged the EU to not understate their value. It shows Israel is a worthy and stable partner for the Arabic countries around it and that economic and trade relations can blossom. He invited EU to take an active part in these new developments.

Mark Pritchard mentioned the United Kingdom's upcoming enhanced trade deal with Israel and the strengthening of relations between the two countries. He denounced and condemned discriminatory practices such as BDS (Boycott, Divest and Sanctions) and stressed the importance of partnership between Europe and the only democracy in the Middle East.

Sharon Weinstein thanked ECPM and Bert-Jan Ruissen for conducting "faith-based diplomacy: channeling Biblical support for Israel into real political action".

Members of Knesset who sent video messages to the conference criticized an EU member state's decision to label products from disputed territories, reminding everyone that the decision also affects the thousands of Palestinians working in those factories, farms and fields.

The keynote speaker, Andrew Tucker, showed the shaky foundation on which the two-state policy is predicated upon, the ways in which international law concepts have been (mis) used when it came to the territory and the two-state solution, demonstrating that the policy is rather political. He, for instance, showed a few instances where EU statements and positions went against the Oslo accords from the 1990s.



An important criterion for a state to be recognized is the presence of a robust, legitimate government, which Palestine has failed to produce, despite heavy European funding and support.

The conference ended with reactions from the present audience and contributions from those watching online.







The Bridge conference is European Freedom Network's annual anti- trafficking conference which gathers advocates, experts, therapists and data researchers/ social scientists from Europe, US and beyond who share best practices, new findings and practical ways

of engagement in the fight against human trafficking. This year's event counted 309 guests, anti-trafficking experts and ministry leaders from 43 different countries across Europe who gathered online over a 5-day period to address specifically labor trafficking

and the issues around measuring the impact of trafficking. Many of the EFN members are on the front lines, faithfully serving survivors of human trafficking, while others work in prevention and advocacy.

At this year's conference EFN launched its fourth Don't Shut Your Eyes campaign video, which focuses on labor trafficking and online exploitation. The campaign premiered on October 18 all around Europe, coinciding with the European Anti-trafficking Day.



Participants were encouraged to show determination and courage in further promoting Christian- democratic values at national levels, as well as at the European level. The panels and lectures focused around issues like national sovereignty, family values, religious freedom, Christian identity, media freedom and cancel culture trends.

Trust and Distrust. Experiences and Lessons from the Coronavirus Crisis

In collaboration with our associate-SGP International- we organized a two-day event featuring lectures and workshops by specialists in economics, media and politics who focused on the idea and level of public trust. In the current context of the COVID-19 pandemic, there has been a sharp increase in misinformation, conspiracy theories or even official statements from public figures which were misleading or contradictory. The speakers presented statistics which showed a worrying decrease in public trust by the general population: distrust in politicians, in public health figures and in media. There is also a general pessimistic view on the state of the economy worldwide.

The first speaker focused on the conspiracy theories around coronavirus, the risks of these conspiracies (it weakens legitimate criticism, it marginalizes the weak, it poisons politics), and the role of social media.

The second speaker focused on lessons for the church: the importance of freedom of religion, liberties for Christians, church as a sacred place. The workshops that followed focused on the economic aspect (a "pilgrimlike" way of consumption), on education (home schooling, how to help students who struggle at home) and healthcare system (lack of resources, overloaded healthcare, investment in healthcare system and longterm plans).

The evening session, followed by a panel discussion, focused on the challenges politicians and the government had to face dealing with the pandemic. It was acknowledged that mistakes were made but that overall, the authorities handled it to the best of their abilities.



Cornerstone Dinner

The annual Cornerstone dinner took place again in Brussels, after a hiatus last year, caused by the pandemic restrictions. It was jointly organized with the Cornerstone Team, an informal network of young professionals. Nearly fifty young professionals had the opportunity to meet, network, and discuss the ways they can implement Jesus' principles in European politics.

MEP Lukas Mandl shared personal experiences from his work in the European Parliament as well as from his involvement with Parliamentary Prayer Breakfasts across Europe. He underlined several traits of the person and character of Jesus and discussed how these characteristics could be translated into political action and participation in society. Justice, freedom, human dignity, love were values preached and enacted by Jesus and His followers and also the foundation of our democratic societies.

Ambassador Richmond spoke about the importance of knowing your name and who you belong to; of knowing your identity. He exemplified the importance of that for every person, by providing a story from his work with human trafficking survivors where in the process of enslaving and dehumanizing them, their captors changed their names. Once

free, the survivors found getting their names back and being called by their real names an essential step in their recovery and reintegration.

Finally, ECPYouth President Pieter Smits presented the youth group's vision and work when it comes to young people's participation in European affairs. The aim of their work is to equip and connect young professionals from all over Europe interested in working and leading in accordance with Christian–Democratic principles. He also informed attendees about the upcoming projects and events of ECPYouth.

ECPM General Assembly- 22nd edition


ECPM held its 22nd general assembly on October 15 in hybrid mode: the ECPM board and staff were in Frankfurt and the members joined on ZOOM.

All ECPM members and associates, as well as affiliated organizations were invited to attend, since we elected the new ECPM President and confirmed two new board members.

Building Back a Better Europe


Relational thinking for a Post-pandemic Europe



United Against Sex Trafficking in Europe






On the European Day Against Human Trafficking, ECPYouth, in collaboration with Womanity for All, organized two online meetings, on October 18th and November 23rd. During the first meeting, the participants learned about the context of human trafficking in Europe: the figures, the demographics of victims, the various forms of trafficking, the relevant agencies and authorities, etc.

During the second meeting, six representatives from Romania, Moldova, the Netherlands, Lithuania, Belgium, and North Macedonia presented the best practices against sex trafficking in their countries. The participants reached the conclusion that criminalizing the sex buyers is the best way to fight trafficking and exploitation and that more needs to be done in terms of reintegration of survivors of trafficking into society. Based on these meetings, ECPYouth is preparing three resolutions to be tabled in the future ECPM general assembly.

ECPYouth Resolutions

Digitalisation and Artificial Intelligence

Digitalisation has become an undividable part of our lives and is progressing at unprecedented speed. Digitalisation is an essential component of the EU's response to the economic crisis caused by COVID-19. As such, the COVID-19 pandemic has made the need to accelerate the digital transition in Europe more pressing. The European Union together with the whole world was from one day to another sentenced to distance education, jobs even family and friends encounters. The undeniable need for technology, high-level cybersecurity, a fully remote job market and better data transfer has been proven. European businesses and citizens alike need an adequate policy framework and appropriate skills and infrastructure to capture the enormous value created by the peak of the digital economy during a global pandemic. Digitalisation and Artificial Intelligence can provide for reaching the goals of a greener, sustainable and economically more developed European Union. However, the EU is still far from fully grasping the challenges brought by an abrupt increase in digitalisation. Considering the Treaty on the Functioning of the European Union (TFEU) in particular Articles 4(2)(a), 26, 27, 114 and 115 TFEU. Furthermore, Article 173 TFEU with its focus on improving the EU's industrial competitiveness. Articles 179 and 180 TFEU, which are the legal bases for EU and Member State action in the fields of research and technological development.

Stressing the need for opening debates between EU institutions on immediate actions towards improvement of digital sovereignty of the EU and its Member States preserving fundamental freedoms including data protection and privacy, safety and security, Stressing the importance to provide access to distance learning to all groups of society. As well as equal opportunities to achieve digital literacy and access a job market. Support digitalisation of small and medium business in the spirit of fair competition and equal opportunities.

Stressing the need for promotion of the use of digital tools for judicial proceedings on local national levels without undermining fundamental principles such as the independence and impartiality of the courts, Emphasising the awareness and focus on cybersecurity that should be encouraged within the Member States enabling organisation, small business and citizens to protect themselves from cybersecurity threats, Emphasising the need to strengthen the resilience and data security of health system globally used for data storage in the fight of a global pandemic. Accordingly, train and support health care professionals and medical staff in order to achieve equal and easy access to medicine.

Emphasising the immense importance of data protection and data security in relation to public electronic identification, e-health system, green card certificates and globally implemented IT systems.

Supporting the contribution to the development of Artificial Intelligence conditioned on ethical and human-centric approach with emphasis on safety and liability, in particular for autonomous vehicles and IoT products, Emphasising the importance to set out a common EU legal and policy framework for implementation of Artificial Intelligence bedded in the fundamental values.

1. Calls upon the members of the European Parliament of ECPM to table new tailored initiatives with a solution on gaps created by insufficient digital EU sovereignty impacting social disadvantaged groups of society.

2. Calls upon members of the European Parliament of ECPM to vote for digitalisation embedded in fundamental values and human rights, putting human dignity and life first.

3. Calls upon the European Commission and members of European Parliament of ECPM to increase Al and tech awareness through the national and international organisation, trade unions, non -profitable organizations, representatives of the Member States.

4. Calls upon the European Commission and members of European Parliament of ECPM ensure digitalisation of health, regulatory, privacy, data cloud storage, and any other IT systems that are secure, protect personal data, do not discriminate and share fundamental rights and values.



ECPYouth Resolutions

Building sustainable recovery post-pandemic

Considering the Universal Declaration of Human Rights (UDHR) and other UN human rights treaties and instruments, particularly the International Covenant on Civil and Political Rights, the European Convention for the Protection of Human Rights and Fundamental Freedoms (ECHR) and the protocols thereto.

Considering the Treaty on European Union (TEU), the Treaty on the Functioning of the European Union (TFEU) and the Charter of Fundamental Rights of the European Union.

Considering the Council of Europe publication of 7 April 2020 entitled 'Respecting democracy, rule of law and human rights in the framework of the COVID-19 sanitary crisis.

Considering the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation).

Considering the Oddessa declaration with emphasis on equality, cooperation and sustainability as well as human dignity.

Referring to the imposition of government measures balanced against the fundamental human rights, values and democratic accountability, additional scrutiny of the governments in establishment of the state of emergency providing the national parliaments with added regulatory discretion.

Stressing the importance of democracy, rule of law and fundamental rights as they affect the exercise of individuals rights for freedom of movement, freedom of assembly, freedom of religion, the right to family life, non-discrimination, privacy, right to work and right to education.

Stressing that steps to be taken for recovery shall consider the basic human rights; where governments actions shall reduce the potential negative impact of such measures on people's lives.

Stressing the need to balance the right of expression with the right to information in pursuance of the fight against disinformation. Providing support to ensure media pluralism, in order to ensure transparency, objective information to diminish disinformation that distorts scientific knowledge about health risks and justifies the legitimacy of the fight against the spread of COVID-19.

Stressing the importance of recovery built on a more sustainable, inclusive and fair economic model based on social and relational market economy, where the environment is respected, digital innovation is put into services, the job market is re-newed and financially aided, whilst basing the recovery phase on basic fundamental rights and values.

Stressing that the recovery plan and funding should be conditional on providing decent jobs, transparency on paying taxes and working towards agreed climate goals through the transition. 1. Calls upon the members of the European Parliament of ECPM to put the values of equality, cooperation and sustainability of the Odessa declaration first in discussing and drafting recovery plans.

2. Calls upon the members of the European Parliament of ECPM to promote sustainable recovery plans with fundamental human rights in the middle with focus on the re-building job market, creating equal opportunities, support and aid education for all social groups, strengthens health care and social infrastructure.

3. Calls upon the members of the European Parliament of ECPM to embed the Sustainable Development Goals in the recovery plans.

4. Calls upon the members of the European Parliament of ECPM to actively engage in dialogues with the national parliaments to help them navigate in recovery plans aimed at transparency, equality and sustainability.

5. Calls upon the members of the European Parliament of ECPM to vouch for access to education and assurance equal access to education for everyone.

6. Calls upon the Member States to respect the right of expression and access to objective information, ensuring personal data protection and make sure that the technology employed to fight the pandemic to be fully in line with the right for privacy and transparency in order to protect data leakage.



ECPYouth Resolutions

Sustainable Europe

Considering the international treaty of the Paris Agreement on climate change with the common goal of reaching green gas emission and sustainable business, social and political actions;

Taking notice of the common democratic values of the EU, the role of the European Parliament and the European Council in the conclusion of the international agreements and division of powers referring to article 3(3) TEFU;

Stressing the human-generated greenhouse gas emissions from fossil fuel combustion—exacerbated by unsustainable land use such as deforestation—are a leading cause of climate change;

Stressing deforestation and wildfire suppression are making forests more vulnerable to fires and reducing the ability of forests to sequester and store carbon;

Stressing that climate change impacts everyone, already vulnerable populations globally will be disproportionately affected, exacerbating unemployment, displacement, and homelessness;

THEREFORE, BE IT RESOLVED that European Political Christian youth, in the pursuit of climate justice,

Affirms its support for the development and proliferation of renewable sources of energy and fuel, particularly wind and solar, and

Affirms its support of sustainable land use, forest conservation, and reforestation, and

Affirms where direct restrictions are insufficient, support for a price on climate-damaging substances and practices through a carbon tax and other related disincentives, and

Affirms political and financial incentives for a global industrial refitting of our power infrastructure away from fossil fuels and toward sustainable energy production and storage.

Emphasising the importance of new initiatives on sustainable travel, better and more accessible railroads between European cities, sustainable development, sustainable economics and sustainable relations based on democratic and equal relational values;

Emphasising the Odessa declaration core values which include "dignity and cooperation with organizations, as well as underprivileged groups of society, equality, sustainability and subsidiarity", these shall be reflected in any new green initiation of the EU, execution of targets set out in the Paris Agreement;

Stressing that Article 7 of the Treaty on European Union makes space for the European Commission, European Parliament and groups of Member States to express their opinion on upholding of the common values; 1. Calls upon the members of the European Parliament of ECPM and Member organisations of ECPM to promote common democratic and equal values in the conclusion of international agreements that contain a provision on sustainable development and climate goals;

2. Calls upon the members of the European Parliament to call upon the Members of the European Council, expert committees and representatives of the Member States and Member organizations of ECPM to implement new initiatives on sustainable travel, and better and more accessible railroads between European cities, held meetings and encounters online in order to restrict unnecessary travels, supported initiation of the Member States and international organisation on the promotion of "green travel", and set an example;

3. Calls upon the members of the European Parliament of the ECPM to consider the core Oddessa values in transition to a carbon-free environment;

4. Calls upon the member of the European Parliament of ECPM to remember the underprivileged groups of society who are dependent on carbon production industry and create equivalent job position or other life providing alternatives;

5. Calls upon the members of the European Parliament of ECPM to democratic, European and Christian values in the dialogues with the European Commission on the persuasion of the "green goals".

Belarus Statement

Stop the terror! Release the Belarusian Youth!

Considering that Belarus is becoming more and more a totalitarian dictatorship where not only political or social activity but also any kind of disobedience including white and red colors are forbidden;

Taking into account that:

- -more than 40.000 Belarusians were detained during the last year and about 5000 criminal cases were initiated;
- -at least every third of the detained was a young person;
- -at least 14 people under 18 are sentenced to different terms in prison for peaceful protests;
- -Belarusian students were made political prisoners for organizing legal strikes;

We demand on the Belarusian regime:

- -To stop political repressions in Belarus
- -To release all the political prisoners, including the young ones
